INDEPENDENT SOLO ENTRY FORM PROCEDURE:

(Do Not use this form if you are competing in at least one number in the National Finals)

- 1.) You must use the **Official Tremaine “Dancer Of The Year” Solo Entry Forms** (*enclosed*)(*no exceptions*)
- 2.) **Completely** fill out all forms leaving no blank spaces.
- 3.) Enclose **ONE CHECK for total Convention Registration fees** for all participants
- 4.) Enclose a **SEPARATE CHECK for Independent Solo entry.** (\$100 per dancer)
Note: All Contestants must be Pre-Registered for entire convention.

RULES & REGULATIONS

WHO IS ELIGIBLE TO COMPETE AS A “DANCER OF THE YEAR” INDEPENDENT SOLO ?

1st, 2nd & 3rd place winners, all categories, all divisions, from the **2010/2011 Tremaine Semi-Finals Competitions** held between **October 2010** and **April 2011** and **NOT** competing in the **2011 National Finals.**

TIME LIMIT ON ROUTINES:

Solo **1:45** minutes (Costume Optional)

SOLO MUSIC: **Do not mail Solo Music to the convention office.*

Music on CD, clearly marked with your name

MISCELLANEOUS:

- All contestants must be registered for the entire 5 day convention.
- Routines must be appropriate for family viewing.
- **Convention Fees and Competition Fees** must be submitted at the same time, on **Separate Checks.**
- No Teachers may perform.
- No Professional dancers.
- No beginner students.
- No Scenery or Dangerous Oversized Props. *TDC reserves the right to disallow the use of any oversized or dangerous props.*
- No use of live animals.
- No use of Fire in any way.
- No Glass on stage.
- No singing. Lip sync O.K., Talking O.K.
- General props O.K.--**To be moved by performer ONLY!!!**
- Contestants must automatically grant permission to Tremaine Dance Conventions, Inc., to use their image (photo or video) for advertising and publicity purposes in connection with the conventions and competitions.
