Company Members

Company Description:

The Tremaine Performance Company is made up of an elite group of dancers who desire to achieve a higher level of commitment and training in the art of dance and/or a career in the dance industry. More than a dance "school", The Tremaine Performance Company will position itself as the *premier* program of choice – known for its dedication to excellence and high standards of instruction.

The Company's ultimate goals are:

1. To contribute to each students' growth by enabling expression through dance
2. Increased health through exercise
3. The development of positive social interaction through class participation, traveling opportunities and performing in all areas of the United States.

Students will be evaluated yearly. Members will then commit to a specified number of training workshops, choreography sessions, rehearsals, live performances and assisting weekends at Tremaine Conventions within a one-year period. Dancers who would like to continue in the program the following year will be required to fill out an Evaluation Application in order to be considered.

Company Requirements: *Please note that requirements are subject to change.

Studio Dance Training:

It is important that these dancers understand that this program is in addition to their current training, which should not be compromised while participating in the Tremaine Performance Company. This program is not made to take the place of technical work and classes in their home city, but to enhance the dance experience and performance skills. Participants will be required to take a certain number of classes weekly at their current studio along with the traveling training and performance requirements.

These requirements are as follows:

1. 3 or more ballet classes per week (taken in their home studio).
2. 2 or more jazz classes per week (taken in their home studio).
3. 2 or more elective classes per week (dancer's choice).

Training Camps and Workshops:

Tremaine Conventions will offer Training Camps each year in various locations across the country. Camps will be 1 or 2 days in length. Locations will be determined and members will be notified. Dancers will engage in all styles of dance training as well as prearranged choreography sessions with established industry choreographers to create pieces for the company to perform.

Convention and workshop requirements:

- Must attend at least **7** cities yearly – **6** during the winter season and **1** summer city.
 - A) Minimum of 1 city before December break
 - B) All 6 cities must be completed by the end of the Winter Tour
 - C) 1 summer city of choice

- **Performances:** Live performances will be added as they become available yearly.

Apprentices

Program Description:

This group is made up of dancers that are asked to participate by Tremaine Dance Conventions following the audition. These dancers are apprentices for the Tremaine Performance Program. Dancers that are not yet ready for the performing company will be encouraged to participate in this program for one year before their next audition. These dancers will be eligible to attend workshops and choreography sessions with the Tremaine Performance Company members and understudy the company's pieces.

Program Requirements:

- Must attend at least **5** cities yearly – **4** during the winter season and **1** summer city.
 - A) Minimum of 1 city before December break
 - B) All 4 cities must be completed by the end of the Winter Tour
 - C) 1 summer city of choice
- May demonstrate at the discretion of the faculty member giving class.
- Work competition.
- Required to meet all requirements set forth in the "Tremaine Assistant Handbook"

Alternates

1. Dancers not ready to participate in the full program will be monitored for the first 3 months of the winter season. Dancers must attend at least 2 cities before the December break to be reviewed. Over the break alternates will be notified by TDC about program status.
2. Dancers in the program who have been moved to the alternate list will be evaluated on an individual basis. If you are placed on this list, you must immediately contact Desiree at d@dezworld.com.
3. All costume, choreography and tuition information will be the same as apprentices. Performing in the show will be at the discretion of the director.

Frequently Asked Questions

Please read the following guidelines for frequently asked questions of our assistant and scholarship winner programs.

1. "How do I become an assistant with Tremaine Dance Conventions?"
Answer: If you are interested in becoming an assistant with Tremaine you must audition for the Program this summer in Los Angeles. See information under "The Audition" for information. No DVD submissions will be accepted. Must be present for audition.
2. "If I received a year long scholarship, does this mean I get to assist at convention and dance in the show?"
Answer: No. Your scholarship only secures you free tuition to our conventions, not immediate participation in assisting and performing in the show. If you would like to be a part of one of the programs, you must audition this summer in Los Angeles.
3. "I am a past DOTY. Does this mean I get to assist and participate in the show?"
Answer: No. As a past DOTY you will fall under the same requirements all other dancers follow. This way we keep the level of excellence to the highest competitive level. Each and every dancer will have to audition or evaluate yearly to renew their spot as an assistant or in the Tremaine Performance Program.
4. "If I am currently in the program and attend a convention with my studio, does this count towards my city requirement for the year?"
Answer: Yes. Any Tremaine Convention you attend during your year in the program counts towards your requirement for the year whether you are there with your studio competing or there as an assistant.

Additional notes about our program:

Dancers who would like to continue in the program the following year will be required to fill out an Evaluation Application for consideration. You do not have to attend the Tremaine Intensive to take part in the audition in order to continue in the program next season.
