**If applicant is 13 at time of audition but will turn 14 by October 15th, you are eligible to be considered for the Teen or Senior Company. Company Placement is at the discretion of the Director.

***Any applicant who turns 19 during the 2022-23 Season is only qualified for the Pre-Pro Company.

****Teachers are not permitted to audition, but working/professional dancers are allowed for the Pre-Pro Company.
